## **MAKING YOUR CONTRIBUTION WORTH MORE**

We hope that members who are UK taxpayers will take advantage of the opportunity to pay their subscriptions and make donations under the Gift Aid scheme, which enables relief to be given for UK tax on contributions to the Friends of Mount Athos, to the benefit of both the charity and the donor.

The scheme provides a highly effective way of making your contribution to the Friends worth more to us at no extra cost to you. Under it, the Friends can recover the basic rate tax (equivalent to 25% of the net sum donated) from the tax which you have paid to Her Majesty's Revenue & Customs (HMRC), meaning that for every £1 donated under the scheme, 25p may be claimed back. Therefore, if you pay your subscription at the minimum annual rate of £40, we can claim a further £10.00.

If you pay tax at 40%, you can also claim higher rate tax relief on your Gift Aid donation. In the example quoted, this would amount to a further £10 in reduction of your personal tax liability. Additional rate taxpayers benefit even more.

To make a Gift Aid donation, all you have to do is complete the simple declaration attached to this form and return it to the Honorary Secretary with your donation and subscription.

Please note however that the scheme cannot be used by members who do not pay sufficient UK income or capital gains tax to cover the reclaim which the charity will make.
